Dear Mr Scarisbrick

As you know, 26 The Bramptons has been purchased by the Board as the parsonage for the benefice of West Swindon and The Lydiards, replacing Shaw Rectory which was, until recent times, the Team Rector's residence.

During the process of purchasing the replacement parsonage, it came to light that when the Team Ministry was created in 1986, the residence for the first Team Rector was designated as Lydiard Millicent Vicarage. However, subsequent Team Rectors lived at Shaw Rectory and Team Vicars have resided at Lydiard Millicent, but the legal status of the properties as Rectory (parsonage) and Team Vicarage (glebe) respectively was never corrected.

So, we have a situation whereby Lydiard Millicent Vicarage needs to be transferred to glebe status, as the Team Vicarage, for which I enclose a Statutory Notice under the Endowments and Glebe Measure.

Please let me know if you have any questions about this Notice. If you or the PCC wish to make an adverse representation, I need to receive it by 31 May. It will also be helpful if you can confirm that you do not wish to raise any objection.
